Sebelum ini, komponen elektronik diklasifikasikan di bawah lain-lain jentera elektrik.

2 As from 1986, data have been reclassified into electronics and electrical machinery and appliances. The electronics sub-sector comprises semiconductors and electronic equipment and parts (mainly automatic data processing machines). Data for electrical machinery and appliances refers to consumer electrical products (mainly audio-visual products), industrial and commercial electrical products (mainly telecommunications equipment), electrical industrial machinery and equipment (mainly air-conditioners), and household electrical appliances (mainly rice cookers, washing machines, refrigerators, etc.). Previously, electronic equipment and parts was classified under other electrical machinery.
