1 The production of the Mining Sector is represented by the production of tin ore, copper ore, crude petroleum and natural gas, which accounted for 99.2% of the Census Value Added of the Mining Sector in 1993.

2 The production of the Electricity Sector is represented by the generation of electricity by the public sector which accounted for 95.9% of the total electricity generated in 1993.

3 This index was rebased to 1993 and now refers to the production of 64 industries selected from 23 major groups, covering 433 commodities. The selected industries accounted for 71.1% of the Value Added of the Manufacturing Sector in 1993.
